Members may receive a pink or blue card in the mail to fill out and return in the envelope provided. If you return the card in the envelope provided you will receive a call from American Income Life to offer you more insurance. You may give or send the card to your membership trustee and it will be forward to the state. Also when you are filling out your application the bottom portion is for the AD&D insurance. If your information or your beneficiary has not changed you do not need to fill the insurance portion out just put an 'X' through that area. If you wish to have more than one beneficiary you can write it on the back of the application on the lower part of the page. If your beneficiary is someone that rides with you it may be a good idea to have a second beneficiary. Also if an event happened in your life (marriage, death, birth, or divorce) you may want to complete the lower portion if you are unsure as to whom your beneficiary was. Please keep in mind AIL does offer a variety of different types of insurance and they are reasonable. If you would like to contact AIL for information on insurances provided please call your membership trustee for the phone number. If you have any questions about the insurance please feel free to call Brandy at the state office 386-943-9610.



Importance of Keeping your Membership in GOOD Standing

For those who are unaware; if you allow your membership to become delinquent ALL your ABATE privileges and benefits are suspended. This means you do not have the AD&D insurance coverage and your voice in voting is not heard while your membership is delinquent. With elections for Forest Chapter fast approaching if you want to be a part of Forest Chapters future it is important that your membership be in good standing with ABATE of Florida, Inc. This means the membership trustee must have your application and payment in hand by May 28, 2023, whether it is a renewal or new membership. This will allow you to vote for the next board of directors for Forest or be eligible to run for a position on the future board of directors. If you renew a delinquent membership or become a new member after May 28, 2023 you will not be able to vote at the June meeting.

\$9.6 MILLION VERDICT AWARDED TO INJURED MOTORCYCLIST

On November 11, 2018, Joe S. was riding his motorcycle at a lawful rate of speed south bound on North Citrus Avenue in Crystal River, Florida and had the right of way. A north bound sport utility vehicle turned left in front of Joe S. violating his right of way. Joe S. and his motorcycle slammed into the passenger side of the sport utility vehicle, and he sustained severe facial lacerations and multiple fractures to his left arm and pelvis. First – Responders called for Joe S. to be transported by Life Flight helicopter immediately to Ocala Regional Medical Center’s Level Two Trauma Center. Doctors and staff there saved Joe S.’s life and performed multiple surgeries on his face, left arm and pelvis. After seven weeks in ORMC, Joe S. was discharged home into the care of family members. His serious and permanent injuries have had a profoundly adverse effect on his quality of life.

Ocala personal injury and motorcycle accident lawyer, Dan Hightower, filed a negligence lawsuit on behalf of his client, Joe S. in Citrus County, Florida in 2019. During the week of February 10, 2020, Mr. Hightower tried the case in Citrus County Circuit Court. After the conclusion of the trial, a verdict was rendered by the Court in favor of Joe S. and against the Defendant SUV driver for \$9,661,232.98.

When asked for comment on the verdict, Mr. Hightower simply said two things: 1) “Justice was served” and 2) “Watch out for motorcycles.”

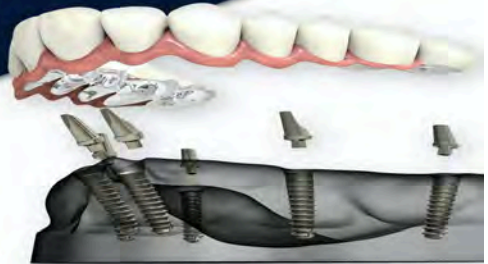
